

Cyngor Cymuned Tregynon Community Council

Minutes of Tregynon Community Council's meeting held on 13 July 2023 at 7.55 pm in the community centre, following the Wind Farm Trust meeting. *Present at start of meeting:* Cllrs J. Shearer, T. Breese, M. Watkin, M. Davies, D. Bumford, W. Jones, H. Hulme and S. Williams, and the Clerk Rachael Jones. Cllr Shearer handed in a playground inspection sheet.

The councillors welcomed Mrs Hannah Morris as the new co-opted councillor. Mrs Morris signed the acceptance sheets and joined the council.

Declarations of interest: None.

Minutes: The councillors reviewed and accepted the minutes of the June 2023 meeting and the AGM. The Chair then signed the minutes. *Matters arising:* None.

Planning: None. Councillor Hulme reported that the Pwllan mast development is to go ahead.

Applications received after distribution of the agenda, at the discretion of the Chair: None.

Highways: Olivers Lane has been reported to be in a poor condition. Work has started on installing new speed signs through the village in preparation for the 20 mph limit that will be introduced in September. There is no news on the community Speedwatch. Cllr Jones reported that the belisha beacons to be needing attention and Cllr Hulme is to follow this up. Cllr Bumford showed the new electronic traffic sign. A footpath in the centre of the village has been trimmed and some road sweeping has been carried out. Parking matters were discussed. Cllr Hulme read out the traffic data that has been collected on the Bettws Road and the average speed past the new development was calculated to be 38mph. The council will install 30mph repeater signs and the clerk will write to Highways to confirm.

Cemetery: There is going to be a new headstone.

Playground including cone: The Chair has heard that the manufacturer of the cone are willing to send new bearings but the council will have to find an installer. Clerk to write to Hanratty's to state that either the manufacturer installs the new bearing or the council will seek a refund of the cost of the cone.

Amenity land: Clerk to write again to Callum Foulkes to seek a meeting with Cllr Breese. Clerk to check the 3-year agreement held currently with Gwynne Woosnam for groundworks.

Finance: Current account- £8446.30; Reserve- 12,019.83. One invoice was approved: Gwynne Woosnam (Groundworks) £2100.00. The councillors decided to write the cheque for the new electronic speed sign.

External reports: The parochial charities committee is to have a meeting. Cllr Hulme had earlier sent around her monthly report.

Correspondence: None. *Any other business:* The councillors agreed that if Cllr Bumford incurs any expenses related to installing the new speed sign, he is to be reimbursed.

Items for next agenda: Cone; grass-cutting contract.
